Data subjects' rights

ARTUR RAMON SL informs its Users that they may exercise their rights of access, rectification, restriction, erasure, portability and objection to processing their personal data, and the right not to be subject to automated decisions, including profiling, before the Data Controller, and also withdraw the consent given.

- **Right of access:** This is users' right to obtain confirmation about whether their data are being processed and, if so, the specific personal data being processed and the statutory information about the processing (purposes, legal basis, storage periods, disclosures, origin of the data, etc.).
- **Right to rectification:** This is the data subject's right to correction of inaccurate or incomplete data. In the case of the website, any such correction can only be made for the information that is under the website's control, for example, deleting comments published on the website itself, images or web content that contain the user's personal data.

 - The request may be made by the legal or voluntary representative when such person is duly identified and authorised by the data subject (by means of an express authorisation given by the data

subject to exercise the personal rights regulated in personal data protection regulations).

- The specific right that it is intended to exercise. If no reference is made to a specific processing operation, an answer will be given concerning all the processing operations involving the data subject's personal data. If information is requested about a specific processing operation, only the information about this processing operation will be given. If the request is made by telephone, the data subject will be asked to request the information in writing. Information will be given on how this can be done and the address it must be sent to. Information will never be given over the phone.
